



# **EXHIBITOR REQUIREMENTS**

- To gain approval from the Royal International Convention Centre (RICC) to offer beverage sampling at the event, this form MUST be completed and return to <a href="mailto:exhibitorrequests@rna.org.au">exhibitorrequests@rna.org.au</a> no less than 21 days prior to the commencement of the event.
- All items being sampled MUST be directly related to the exhibitors core business
- Exhibitors who submit forms late risk not being approved to sample their products

#### MANDATORY SUPPORTING DOCUMENTATION

- Copy of your current Liquor Licence in Qld or another Australian State or Territory
- Copy of Queensland RSAs or Statement of Attainment from a nationally registered training organization for all personnel that will be serving alcohol

All persons serving alcohol are to have an RSA issued in QLD or a Statement of Attainment displaying the following Nationally Recognised Training logo



You can only use your interstate RSA qualification in Queensland if it's a Statement of Attainment from the nationally accredited Provide Responsible Service of Alcohol course. This is the only nationally recognised qualification. If you don't hold this specific Statement of Attainment, you'll need to complete the nationally accredited course through an RTO,

Not only is this a condition of operating under the venue liquor licence, it is also a requirement of the Office of Liquor and Gaming Regulation. ### MANDATORY REQUIREMENTS

Provision of samples must be free of charge and no more than –

Beer – 50 ml Wine – 30 ml Spirits – 10ml Non-alcoholic - 50 ml

- Exhibitors must comply with Responsible Service of Alcohol guidelines
- Covered spittoons
- Plastic sampling size cups to be 50ml or less in size
